MINISTER'S COLUMN, Scott Couper

Dear Friends:

Greetings On the last Sunday of July, I preached a message entitled "Soul Investment" that requested our church explore, research, and discern if our Finance and Endowment committees should begin the process of investing our church's funds in ethical and sustainable growth investments. The theme of my message is that while we can never hope to be pure from all sin, we can together faithfully 'move in the right direction'.

Soon after I preached this message, Allen Myrick also spoke to us through the Spirit, that continues to move us through his poetry. For Friday, February 8, 2008, Allen wrote this devotional prose:

Your work on me has just begun. There's much more you have to do Before your purpose is fulfilled. Loving kindness grafted in me, growing through me is your will-Faithful, patient, resourceful love poured out, naught held back. What a task you've set for yourself!-to form in me the very love you gave to all the world in Christ, to make an ambassador for you to humankind.

Do not leave your work half-done; Finish the job you have begun!

In writing "Soul Investment", I wanted to emphasize that more often than not God's salvific intent is directed to groups of people rather than to individuals. God and Jesus when praising or admonishing, often refer to 'tribes', 'nations', 'generations', 'cities' such as Jerusalem, and even to 'empires'. Paul speaks of and to 'churches' as much as to 'persons'. Hence, sin is corporate or social as much if not more than it is private or individual. This is major theme in the works of two prominent theologians, Dietrich Bonhoeffer (Santorum Communio) and Reinhold Niebuhr (Moral Man and Immoral Society).

In writing "Soul Investment", I also wished to avoid being a hypocrite, the worst accusation Jesus leveled at his foes. A hypocrite is someone who promotes him or herself to be self-righteous while judging and shaming those who are no more fallible. Two years ago, in prayerful response to the witnesses of our friend Daniel Sicken and member Bill Pearson, I disinvested from TD Bank due to their underwriting of a fossil fuel pipeline running near or through indigenous lands. In July, I invested the proceeds from a home sale into an investment portfolio that follows a "Sustainable Equity Strategy". The strategy uses 'general avoidance criteria' to ensure that that my funds do not invest in tobacco, alcohol, porn, weapons, or nuclear power. Companies that have good public health policies, protect the environment, maintain a fair workplace, positively impact communities and practice good governance with transparency are favored.

Outside our church we fly a banner that proclaims "A Just World for All". There is evil and sin within systems from which we can't hope to completely extricate ourselves. By seeking even modest investment returns, the church and I are both guilty of Jesus' admonishment in the Parable of the Rich Fool (Luke 12:13-21). Nonetheless, we can 'move in the right direction'. As Christians, our choice is simple. We can reject the teachings of Jesus Christ and refuse to improve. Or, we can accept the teachings of Jesus Christ (as radical as they may be), confess our falling short, ask for forgiveness, and seek means by which to 'move in the right direction'.

CHRISTIAN EDUCATION



Per her wishes, there will be no services. Private burial in Tyler Cemetery will take place in the summer. Rest well, Mom. You are so loved.


